

Tug of War Federation of India

Memorandum of Association

- Article 1. Name of the Federation** : The name of the Federation shall be
Tug-of-War Federation of India.
- Article 2. Registered Office** : The Office of the Federation shall remain in the
Union Territory of Delhi, and presently at
301, Delhi Chamber Bldg., Delhi Gate
New Delhi-110002
- Article 3. Society Registration** : The Federation is registered with the Registrar of
Societies as extended to Union Territory of Delhi
under the Societies Act XXI of 1860.
- Article 4 . Jurisdiction of Work** : The jurisdiction of work shall be the jurisdiction of
the Supreme Court of India. For all disputes, the
High Court of Delhi will be the court of relief .
- Article 5. Status of Organization** : It will remain solely as a charitable non-political
National Sports federation.

Article 6 Aims and Objectives :

1. To organize and maintain general control of the game of Tug of War in India and keep it on the most efficient lines of sports organization.
2. To promote, develop and encourage the game of Tug of War as also physical education.
3. To impart and provide facilities for training and techniques to players and diffuse useful knowledge to the enthusiasts.
4. To promote and assist in the formation of Districts, Club ,State & UT Tug-of-War Association and give them guidance.
5. To support, establish and maintain research centers for tug-of-War sport.
6. To encourage and aid in the publication of sports literature in the form of books, magazines, pamphlets etc.
7. To be the official organization in complete and sole charge of all matters connected with the game of Tug of war in India.
8. To select teams to represent India in International contests/competitions.
9. To arbitrate in any matter which is brought before the Federation

10. To co-ordinate activities amongst members by holding State, Districts, National level Tournaments/Championships and in other ways.
11. To hold technical clinics, Workshops & Referee , Judges& Coaches Course , Diploma and frame rules and bye laws not in consistent with the Constitution
12. To certify the status of players from India for International - competitions wherever such certification is necessary.
13. To generally do all such other acts as may be desirable or necessary to further the Interest or cause of the game Association/Federation.
14. To maintain regular contacts with the Indian Olympic Association and National Tug of War Federations in other countries and Tug of War International Federation.
15. To receive grants, donations, gifts without condition from State Charitable organizations or any government or non-government organizations or Individual persons or general public and receive credits, loan ,over draft from bank or members, any sports lovers for the promotion of the game.
16. To employ or dismiss any person in employment, or give in contract any administrative duties to persons on behalf of the Federation.
17. To enter into any contract or legal instrument with any Federation, State or non-state organization or appear before any legal Court for the furtherance or protection of any interest of the Federation.

18. To buy or sell any asset of the Federation as and when acquired and maintain an office for its administration.

Article 7 Clause (A) :

All the incomes, earnings, moveable, immovable properties of the Federation shall be solely utilized and applied towards the promotion of its aims and objective only as set forth in the Memorandum of the Federation and no profit on thereof shall be paid or transferred directly or indirectly by way of dividends, bonus profits or in any manner whatsoever to the present or past member of the Federation or to any person claiming through any one or more of the present or the past members. No member of the Federation shall have any share in the profits of the Federation or make any profits, whatsoever, by virtue of this membership.
