The matter regarding renewal of annual recognition to various National Sports Federations (NSFs) for the year 2019 has been examined in the Ministry and it has been decided to renew the annual recognition for the year 2019 i.e. upto 31st December, 2019 to the NSFs indicated in the list at Annexure-I and Annexure-II.

- The Ministry has issued instructions on suo-moto disclosure of information by NSFs on their website vide letter No.9-7/2014-SP-I dated 26.02.2015 (copy enclosed as Annexure-III). Based on the information uploaded by the NSFs on their respective websites on the date of examination, it has been found that while NSFs listed at Annexure-I have complied with the instructions, those listed at Annexure-II have not yet fully complied with the guidelines issued by the Ministry. However, in the interest of sports and sportspersons, it has been decided to renew the annual recognition of the NSFs listed at Annexure-II, who are required to comply with the guidelines by 31.03.2019 failing which their recognition may be reviewed.
- It is also informed that renewal of recognition to Equestrian Federation of India is subject 3. to their compliance of Sports Code within the time frame allotted to them i.e. latest by 03.08.2019 failing which their recognition status will be reviewed and action taken as per extant guidelines.
- 4. Since, the recognition has been made based on the suo-moto disclosure of information by the NSFs on their website, in case it comes to the notice of this Ministry that such information in respect of any NSF(s) is/are not correct, recognition of the concerned NSF(s) may be withdrawn forthwith without prejudice to any other action as deemed appropriate as per the NSDCI, 2011 or any other extant guidelines.

Sub: Information to be hoisted mandatorily by IOA & NSFs on their website - reg.

Sir.

Reference is invited to this Ministry's letter No. 9-69/2009-5P, I dated 29<sup>th</sup> November, 2010 and letter No. 8-20/2014-SP-III dated 15<sup>th</sup> October, 2014 wherein IOA and NSFs were asked to furnish the information to this office and to suo-moto disclose their various activities carried out by them. All these instructions have also been made part of the National Sports Development Code of India, 2011 (copies enclosed)

- 2. It has been noticed that although some of the NSFs are furnishing the required information to this office, it is not available on the websites of many NSFs and hence is not available to general public and stake holders.
- 3. In a recent case of Badminton Association of India vs. Union of India, the Hon'ble High Court of Delhi has taken a serious view about non furnishing of information under RTI Act by the NSFs. Hence the court has passed an order dated 24<sup>th</sup> December, 2014 in W.P.(C) No.9318/2014 stating, inter-alia, that this would be an appropriate case where Government of India should examine the manner in which the NSF is functioning.
- 4. Therefore, in order to reduce the paper work of NSFs while making the information available to stakeholders regarding the functioning of NSFs and IOA it has been decided that henceforth the information as per the enclosed list shall be uploaded on the website of IOA and the respective NSFs.
- 5. All these information should be made available on the website latest by 1.4.2015. Further, the website must be updated by IOA & NSFs as frequently as possible and atleast once in a fortnight.
- 6. Vide order No.8-20/2014-SP-III dated 15.10.2014 it was informed that the NSFs shall post their audited accounts and the Balance Sheet of the previous year by 30<sup>th</sup> June of the current year. It was brought to the notice of this Ministry that finalisation of audited

accounts and balance sheet takes time and it is not possible to post the same on the website by 30<sup>th</sup> June. In view of this, it has been decided that the annual accounts of the previous financial year should be posted by the IOA & NSFs during the current year as soon as it is finalised but latest by 31<sup>st</sup> December of the current year.

- 7. Consolidated list of information to be uploaded on the website of IOA & NSFs is enclosed.
- 8. It is also informed that annual recognition for the year 2015 may be reviewed in case the above instructions are not complied with by 1.4. 2015.



As you are aware, the Ministry has introduced a system of annual recognition with effect from 2010. The federations that submitted requisite documents were awarded recognition for the year 2010. Your federation is one such federation that was granted annual recognition which is valid upto 31<sup>st</sup> December, 2010. In order to receive annual recognition for the year 2011, you are required to submit the documents as per Annexure-I, latest by 15<sup>th</sup> December, 2010.

- 2. In addition, you are also required to comply with the ministry guidelines on tenure and RTI applicability and intimate the action taken by you so far with regard to amendment of your constitution and election bye-laws in order to incorporate age and tenure limits of office bearers; and suo-moto disclosure of information on your website and appointment of a Public Information Officer and an Appellate Authority.
- 3. It may please be noted that if you fail to comply with these requirements you shall not be granted annual recognition for 2011, and would not be eligible to receive assistance under the Scheme of Assistance to National Sports Federations and other Schemes of the Ministry. Further, you would also not be entitled to receive government concessions and facilities such as income tax and customs duty exemption, and railway concession available to recognized National Sports Federations and to exercise the right to select the national team and represent the country in international sports events.
- 4. You are, therefore, requested to submit the information by 15th December, 2010 at the latest.
- 5. The receipt of this letter may kindly be acknowledged.

- 3. The above information is vital not only for the benefit of players but also essential for ensuring transparency and accountability of IOA and NSFs, in the management of public funds. It has been further decided that the aforesaid



- dies shall place their audited annual accounts and their balance sheet on their website by 30th June of every year for the accounts relating to the previous financial year. As informed by letter dated 17.7.2014, mentioned at (i) in para 1 above, the IOA and the NSFs are required to get their accounts audited only by Chartered accountants on the panel of the CAG.
- 4. Failure to follow the instructions contained in this letter as well as those mentioned at para 1 above may entail stoppage of financial assistance, non renewal of recognition etc. All the aforesaid instructions shall form integral part of the National Sports Development Code of India, 2011.

Sir,

I am directed to refer to this office letter No.36-2/2010-SP-II dated 30th March, 2010 regarding declaring NSFs as Public Authorities under RTI Act, 2005. As per these instructions, all NSFs receiving grant of Rs.10 lakh or more in a year have been declared as Public Authorities under Section 2(h) of the Right to Information (RTI) Act. Further, as per the provisions under Section 4(2) of the RTI Act, 2005 it has been made incumbent upon all the public authorities to suo-moto disclose information on the various activities carried out by them.

- 2. It has been noticed that most NSFs have not placed the information on their websites with regard to important activities such as selection criteria and details of the officials, support personnel, technical staff, athletes, etc sent to various international sports events, held in India and abroad.
- 3. For the recently concluded Common Wealth Games at Glasgow, Govt. permitted participation of 322 athletes and officials involving expenditure of

Rs.3.11 crores. It has been brought to the notice of Govt. that a large number of officials were deputed by the IOA/NSFs for which cost has been borne by the IOA/NSFs from their funds and accreditation provided by the Games organizers. It has also been reported that the allowance paid to these officials in some cases was much higher than that paid to the participating athletes. Since the IOA/NSFs are public authorities under the RTI Act and receive substantial Government funds, it is mandatory for them to place the complete information relating to the athletes and officials sent to the event on their website.

- 4. Therefore, IOA and the NSF's are advised to place the following information on their website latest by 20 08-2014:-
  - (i) Complete details of officials who were sent to CWG by IOA/NSFs along with the amount paid such as air fare, boarding and lodging, local transportation, daily allowance etc.

(ii) List of players (along with support personnel) who actually participated in Commonwealth Games.

- 5. IOA and NSFs are also advised to place the following information on their website with regard to the international events held in India and abroad:-
  - (i) List of core probables and basis of their selection.
  - (ii) Details of coaching camps organized including venue, dates and list of participants.
  - (iii) Notification of selection criteria for such events well in advance along with the details of time and venue for selection.
  - (iv) List of the athletes selected.

- (v) Details of athletes, support personnel and other officials sent to the event along with the amount paid to them towards air fare, boarding and lodging, local transportation, daily allowance etc. This is required to be placed on the website within 15 days of the conclusion of the event.
- (vi) Performance criteria which formed the basis of selection, actual performance in terms of timing, distance, etc. and the position obtained by each athlete/team.

- 6. A compliance report with regard to the action taken on para 4 above should be furnished by the IOA and the concerned NSFs by 20-08-2014 to this Ministry. As regards action on para 5 above, the compliance report should be submitted by the IOA/NSFs to SAI within a month of completion of each event.
